Whereas, the Jammu and Kashmir State Rural Livelihoods Mission has been entrusted with the implementation of the Skill Development Programme viz. HIMAYAT by designating it as Action Plan State under Deen Dayal Upadhyaya-Grameen Kaushalya Yojana (DDU-GKY) financed by Ministry of Rural Development, GoI;

Whereas, consequent upon this decision the Mission submitted Action Plan to the Ministry which was approved at a cost of Rs.1601.51 crores with 100 percent Central share from the Ministry of Rural Development covering a target of 1,24,180 youth;

Whereas, Project Applications were invited under the programme from prospective Project Implementing Agencies (PIAs) for providing of training and employment to youth;

Whereas, vide Government Order No.257-RD&PR of 2016 dated 07.09.2016 issued by the Department of Rural Development & Panchayati Raj, National Institute of Rural Development and Panchayati Raj, Hyderabad (NIRD) was engaged as Central Technical Support Agency (CTSA) for appraisal/evaluation of proposals of PIAs;


Whereas, out of 41 Project Applications pending appraisal in NIRD, three proposals have been appraised and recommended by the National Institute of Rural Development and Panchayati Raj, Hyderabad (NIRD) for providing of training under different trades;

Whereas, the recommendations of the CTSA were placed before the State Level Project Review Committee (SLPRC) in its first meeting held on 17-01-2017 which approved the proposal and minutes of the said meeting stand issued vide No.COO/JKSRLM/HMT/01/2016 dated 09-02-2017;

Now, therefore, sanction is accorded to the allotment of Project under HIMAYAT (DDU-GKY) Programme in favour of "M/S Apollo Medskills Ltd" (bearing PRN TN2013CR1985) for providing training and placement to youth as per the details given below:-
